Decision

1. Complainant Shri Trinath Hota is present. Dr. Rabiprasad Mishra, Superintendent of Sanskrit Studies, Orissa, Puri and Shri Harihar Mishra, PIO-cum- Administrative-cum- Accounts Officer, office of the Inspector of Schools, Khurda Circle, Khurda are present. Heard. Perused the case record.
2. The case was earlier heard on 05/09/07 and 05/10/07. It was on 05/10/07, that the Complainant alleged that he had not received complete information in terms of the Treasury voucher (TV) numbers and dates relating to his GPF deposits.. After hearing him the State Commission had directed the PIO to (i) provide on payment,

information as available with them to the Complainant within 30 days, and (ii) transfer u/S 6 (3) a copy of the application to the Superintendent, Sanskrit Studies, Mochi Sahi, Puri for necessary action.

3. Shri Harihar Mishra submitted that in obedience to the orders of the State Commission he had transferred the application to the Superintendent, Sanskrit Studies, Mochisahi, Puri vide letter no. 11794 dated 29/09/07 and available information had been supplied to the Complainant vide letter no. 11043 dated 03/10/07 which had been received by him by 15/10/07 under due acknowledgement in the Issue Register .
4. Shri Rabiprasad Mishra averred that after going through the orders dated 05/10/07 of the State Commission, he contacted the Complainant to submit the statement showing deposit of G.P.F. contributions as the same was not enclosed to his form A application. Soon after receipt of data information from him on 30/10/07, required information was sent to him vide letter no. 774 dated 20/11/07. Obviously, for want of the deposit details from the Complainant, the TV numbers and date could not be supplied early. This was confirmed by the Complainant.
5. From the above discussed facts and as there is no deliberate delay, the case is disposed of and closed.
